## COMPLETION OF PELA TRANSACTION

**PharmAust Limited (ASX:PAA& PAAO)** is pleased to advise the completion of the Pela Transaction. Completion of the Pela Transaction was conditional upon the satisfaction of various conditions including PAA shareholder approvals (which were received on 8th July 2011), completion of due diligence and PAA becoming entitled to acquire 100% of Pela as a result of the Pela shareholders accepting offers to be made to them by PAA.
